ANOW ALL MEN BY THESE PRESENTS:

THAT HE, THE UNIVERSIGNED, ALL OF LEGAL AGE, MAJORITY OF WHOM ARE CITYZEND AND RESIDENTS OF THE PHI-LIPPINES, MAYE THIS DAY VOLUNTABLLY ASSOCIATED CURSELVES TOGETHER FOR THE PURPOSE OF FORMING A CORPORATION UNUER THE LAWS OF THE PHILIPPINES. AND WE HEREBY CERTIFY:

FIRST. - THAT THE NAME OF SAID COMPONATION SHALL BE MONDE DEMMARK NISSIN BISQUIT CORPORATION " ;
