ANOW ALL MEN OF THESE PRESENTS:

THAT WE, THE UNDERSIGNED, ALL OF LEGAL AGE, MAJORITY OF WHOM ARE CITYLENS AND RESIDENTS OF THE PHI-LIPPINES, HAVE THIS DAY VOLUNTAHILY ASSOCIATED GURSELYES TOGGTHER FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE LAWS OF THE PHILIPPINES. AND WE HEREBY CERTIFY:

FIRST . - THAT THE NAME OF SALU COMPONATION SHALL BE MONDE NISSIN CORPORATION. Cas apprehated on 3/8/99
